1. What is the DPS?

The DPS sets out the programme for preparing the LDP. It will guide you through the main stages in the process and tells you when and how to find out more. The Scheme is updated every year to let you know how the LDP is progressing and gives you more details on the next stages and how and when you can get involved.

2. The Current LDP

The LDP provides guidance and policies on the type and location of development that can take place in the region, and helps the Council to plan for the future and make decisions about current planning proposals. The current LDP was adopted in September 2014. A new Plan has to be published every five years so the Council are now preparing the next Plan (**LDP2**), which should be in place by September 2019.

The LDP is supported by several pieces of supplementary guidance, planning guidance and various land use audits which can be found on the Council's Development Planning webpages at www.dumgal.gov.uk/LDP.

The LDP sets the context within which development can happen. Development, whether new or proposed, can affect the lives of people and communities. Therefore we want to involve as many people as we can to inform them of policies, proposals and issues, to encourage them to participate and provide their input as early on in the stage of plan preparation as possible so they have an opportunity to shape and influence the new LDP.

Early consultation allows any conflicts or issues to be raised early on so they can be considered and dealt with before decisions are made. Please note we cannot guarantee everyone will get the outcome they desire; however, we think it is important people can understand how and why decisions are made in a clear and transparent manner.



3. Participation statement - how we will enable you to get involved and have your say

The **participation statement** sets out the level of stakeholder involvement that will take place in preparing LDP2 including: when, how, and with whom consultation will take place.

Throughout the preparation of LDP2, we will consult with:

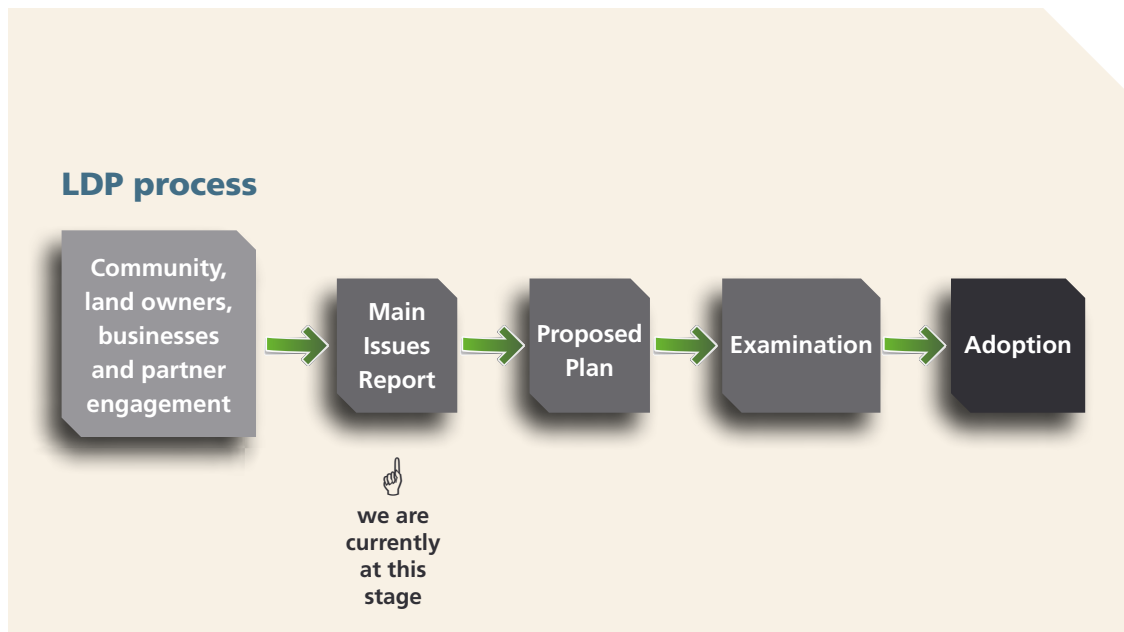
- Stakeholders/key agencies in the public sector (such as key government agencies, statutory bodies, and non-governmental organisations), for example Scottish Environment Protection Agency (SEPA); Transport Scotland and Scottish Natural Heritage (SNH)
- The private sector (such as business interests, landowners and developers)
- The local community including residents, Community Councils, community representatives, community organisations and other interested bodies

Everyone will have the opportunity to engage and comment at the MIR and Proposed Plan stages (see below for an explanation of these stages). Once these stages pass there will be limited opportunity for engagement so it is important to get involved during these periods to ensure your voice is heard.

We will use a range of techniques to consult and communicate with people and provide them with clear information to enable them to make informed comments. We are looking at a range of different and innovative consultation methods in order to reach as many people as possible, as well as continuing with more traditional forms of consultation.

Methods of Consultation will include:

- Press releases
- Adverts in local newspapers
- Posting information and updates on the Council's website
- Directly notifying people signed up to mailing list of any news and updates via The GovDelivery system - this is where people can subscribe to email alerts and updates about the LDP
- Social media such as Facebook and Twitter
- Drop-in sessions in various locations across the region
- We will also explore how we can reach out to younger people as well as other groups of people who may not normally get involved in the planning process



4. Progress so far

An early opportunity for members of the public, landowners, developers and other interested parties to submit details of potential development sites they wanted considered for inclusion in LDP2 took place through a Call for Sites and Comments exercise. The exercise also encouraged people to submit comments they have about the existing LDP.

Six community based workshops were held across the region in August to hear community views on where they live and what could be done to shape how where they live will look and operate in the future. PAS (previously known as Planning Aid Scotland) helped to facilitate the workshops. PAS is a planning and educational charity which helps people to engage with the place where they live. The workshops were attended by 116 people. The **Place Standard** tool, which has been developed by the Scottish Government, NHS Scotland and Architecture + Design Scotland, was used to help facilitate discussion. The Tool encourages people to think about their place and enables them to have a structured discussion around a series of themes and questions. The outcomes from the workshops will be used to inform the MIR.



5. The next steps: Publication of the Main Issues Report (MIR)

The MIR sets out the Council's proposals for development including, where possible alternative options as well as the main planning issues affecting the region and how the proposed new policies and strategies would influence these. It is the first stage of consultation where we will be asking for formal comments to be submitted regarding the proposals and issues.

We will hold a number of drop-in sessions across the region - the list of locations, venues and times is listed below. The drop-in session will provide an opportunity for people to see and discuss what changes the Council are proposing to make to the current LDP.
