We would like to take on the ownership of the Village Hall to continue to run it for the benefit of the whole community. We have been doing this successfully for two and a half years, increasing footfall, enjoyment and contributing to community spirit. We have run fund-raising events, such as Bingo and Quiz and Curry nights and aalso not-for-profit events, such as our Open Show (which is in its fourth highly successful year) and our Christmas Extravaganza which we started with the aim of providing a free family event at a stressful and expensive time of year. We have a dedicated and hard-working Board of Trustees who have worked tirelessly to promote and encourage use of the Hall by community groups both long-established and newly set up. As Chair of the Board, I believe very strongly that Kirkcowan needs its Village Hall. Without it, the village loses a focal point for events, clubs and groups, all of which help to create a sense of community and brings people together. The Hall is particularly important to the Village Primary School, whose School Assembly Hall is not big enough for the parents and carers to come along to watch prize-giving and Christmas plays, and who therefore need to use the Hall for this purpose. It is essential to the sustainability and long-term future of the village that the Hall remains as a vibrant and well-maintained resource. Our plan is to refurbish the Village Hall, particularly to improve its heating, ancient kitchen and bathroom facilities and its issues with damp. When this is done, we believe the Hall will be an indispensible resource for Kirkcowan now and for future generations.
