

#### Why

We wish to integrate the quayside into the Annan Harbour Redevelopment project aimed at revitalising a run-down area, once the beating heart of Annan's economy, which has the potential to regenerate our community and become a hub delivering services for local people.

Aquisition of the quayside elevates the project beyond the physical redevelopment of a tired building into an environmental regeneration project to restore a damaged landscape so that it can sustain life, becomes a regeneration project that will create fulfilling jobs and financial prosperity, is a social regeneration project that will foster and inter-generational community with thriving physical health and mental well-being, and developes as a cultural regenerational project that will celebrate Annan's distinctive local traditions, reconnecing a community with its natural world and putting people back at the heart of its public space.

We will invest in the public realm to facilitate recreational and leisure opportunities for walkers, cyclists and water-sports enthusiasts, with the vision of creating an interchange for current and future active travel routes.

#### Benefits

Our project will restore this historic area and create jobs and training opportunities within the local community
Outdoor volunteering and wildlife talks and tours will benefit 250 people per year through improved physical health and mental well-being

Improved access and connectivity will benefit 50 people allowing them to enage on physical activity

Access to watersports will benefit 80 local peoplewho will take part in rowing, kayaking, canoeing, paddleboarding, wild swimming and sailing increasing options for outdoor excercise.

Landscape interpretation together with craft and skills demonstartions will engender a renewed sense of pride and appreciation of local environment and heritage.

We will run award schemes for young people and activities for older people

The development will attract visitors bringing additional footfall for Annan High Street generating additional spending in the local economy
