- Foul and surface water drainage.
- Water supply, recreation space.
- Fire precautions.
- Car parking space.
- Planting of trees and bushes for amenity purposes.
- Site lighting.

**Note 1**

“Occupier” here means the person who is entitled to possession of the site by virtue of an estate or interest therein, e.g. as owner or tenant. Where the site extends to not more than 400 square yards and is let with a view to its use as a caravan site the application should be made by the person who would be entitled to possession of the site but for the tenancy.

**Note 2**

With reference to Section 8 above the lay-out plan should be drawn to a scale sufficient to show accurately the physical characteristics of the site and the positions of the various items referred to in that section. Normally the scale should be not less than 1:1,250. The lay-out plan shall also incorporate a location plan to a scale of not less than 1:10,000 showing the position of the site in relation to the surrounding district, including roads, etc.

**Note 3**

In the case of existing sites, the plan should show the facilities already available as well as proposals for improvement.

**Note 4**

If the applicant has not already obtained planning permission, he may still submit an application for a site licence but a licence cannot be issued until the planning permission has been granted.

**Note 5**

(1) Residential Sites:- sites in regular, year-round use and occupied by caravans permanently placed on the site throughout the year (where the caravans may be used as the sole or main residence of the occupants).

- (2) Holiday Sites:-
- (i) sites open only for the summer months and perhaps also for part the spring and autumn seasons; and
  - (ii) those sites open during the winter for holiday purposes on which (in either case) caravans are, for the most part, permanently placed throughout the season (where the caravans may NOT be used as the sole or main residence of the occupants).
  - (iii) Touring caravan sites: - sites used by touring caravans by which is meant caravans which are not permanently placed on the throughout the year or throughout the holiday season.
