should be written on the drawings. Details of the astragals, trickle		
vents and method of opening should be detailed on the drawings		
or alternatively provided on a separate drawing		
Proposed vertical cross section of each type of window should		
be provided. Typical window styles will not be acceptable. They		
should be of a metric scale measuring 1:5 or 1:10 and the		
measurements should be written on the drawings.		
Proposed horizontal cross section of each type of window		
should be provided. Typical window styles will not be acceptable.		
They should be of a metric scale measuring 1:5 or 1:10 and the		
measurements should be written on the drawings.
