Thank you for consulting Historic Scotland on the screening report for Dumfries and Galloway Council's Travel Plans Supplementary Guidance received by the Scottish Government's SEA Gateway on 20 August 2014. I have reviewed the screening report on behalf of Historic Scotland in its role as a Consultation Authority under the above Act, in accordance with the requirements of Section 9(3). In doing so I have used the criteria set out in Schedule 2 for determining the likely significance of the effects on the environment. Please note that our view is based on our main area of interest for the historic environment.

My understanding is that this guidance aims to add detail and advice on how to prepare Travel Plans in relation to the requirement of Policy T2 on the location of development and accessibility from the emerging Dumfries and Galloway Local Development Plan (LDP). As this policy has been subject to assessment through the SEA of the LDP I note that the council considers that the guidance is unlikely to have significant effects. In light this and the information contained within the screening report I agree that the guidance in itself is unlikely to have significant effects on the historic environment.

As you will be aware, it is the responsibility of Dumfries and Galloway Council as the Responsible Authority to determine whether the guidance requires an environmental assessment and to inform the Consultation Authorities accordingly.

Thank you for your Screening Report consultation which SEPA received via the Scottish Government SEA Gateway on 21 August 2014.

We understand that the Dumfries and Galloway Council Supplementary Guidance (SG): Travel Plans provides more guidance and information on what is involved in preparing a travel plan and what should be included in a travel plan. The guidance does not provide any new policy guidance, the environmental effects are therefore considered to be nil or minimal.

In accordance with Section 9(3) of the Environmental Assessment (Scotland) Act 2005 we have considered your screening report using the criteria set out in Schedule 2 for determining the likely significance of effects on the environment. Having reviewed the Screening Report, we consider that in respect of our main areas of interest (air, water, soil, human health, material assets (of which we have a specific interest in waste) and climatic factors) the Dumfries and Galloway Council – SG: Travel Plans is unlikely to have significant environmental effects. Although we are of the view that significant environmental effects are not likely, it is for the Dumfries and Galloway Council as Responsible Authority to make a formal determination taking into account the consultation responses received.

Please note that although we do not consider that the SG will have significant strategic effects on the environment we do consider that it may have some effects.
