# 1. Introduction

On 1 April 2017 the UK Government implemented the requirement introduced by the Trade Union Act 2016 for specified Public-Sector employers to report annually on paid time off provided to relevant Trade Union Officials for Trade Union duties and activities.

## Trade Union (Facility Time Publication Requirements) Regulations 2017 (SI 2017/328)

The requirement applies only where the employer has at least one relevant Trade Union Official and 50 or more employees for seven months during the reporting period, which is the period of 12 months beginning 1 April each year.

The report, for the period 1 April 2023 – 31 March 2024, must be published on the employer's website and, where the employer publishes an annual report, it must be included in the annual report.

Therefore, Dumfries and Galloway Council are required to publish information on the facility time usage and financial spend by relevant Trade Union Officials providing the following detail:

- A. How many employees are relevant Trade Union officials;
- B. The total amount spent on paying relevant Trade Union officials for facility time;
- C. The percentage of total pay bill spent on paying relevant Trade Union officials for facility time;
- D. The percentage of the aggregate amount of facility time taken by relevant Trade Union officials that was attributable to specified categories of duties or activities; and
- E. Information relating to facilities provided for use by relevant Trade Union officials in connection with facility time.

This will be required to be undertaken on an annual basis every financial year and is intended to promote transparency and greater accountability regarding the use of public funds for facility time. Local Authorities and Trade Unions will need to ensure appropriate record keeping is in place to meet the requirement to report annually. It will also mean that scrutiny, both locally and nationally, will be more robust.

It should be noted that under the Trade Union Act 2016 the UK government has reserved powers to make regulations limiting facility time to a fixed percentage of an employee's working time.
