

DANGEROUS WILD ANIMALS ACT 1976 (as amended)

CONDITIONS

1. Only animals species stated on the licence may be kept.
2. The maximum number of animals to be kept is stated on the licence any increase in this number must be referred to the Council for approval.
3. The animals shall be kept within the confines of the enclosures provided as detailed in red on the attached plan and inspected by and approved by this department. No new enclosures shall be used for keeping the animals until such approval has been obtained.
4. No animals shall be moved from the premises unless five working days notice is given to the Licensing Authority. Details of the destination of any animals so moved must also be provided. An adequate record of animals movements to and from the premises shall be maintained and made available on request to a duly Authorised Officer of the Licensing Authority.
5. The animals shall not be kept by any person other than the Licence Holder or an Authorised Key Holder approved by the Licensing Authority to act in the Licence Holder's absence. The Authorised Key Holder is Lyndon Scholes.
6. The Licence Holder shall make available at all reasonable times a copy of this Licence to any authorised Key Holder specified in 5 above.
7. Any proposed changes in Authorised Key Holders must be provided to Duly Authorised Officers of the Licensing Authority including the Official Veterinary Surgeon.
8. The enclosure for the animals and the buildings and equipment therein must at all times be maintained in a sound condition and in such a state as to ensure the health and welfare of the animals confined there to the satisfaction of the Service Manager Trading Standards.
9. All reasonable precautions shall be taken to prevent and control the spread of infectious diseases.
10. Adequate supplies of suitable food, drink and bedding materials shall be provided at all times and the animals shall be visited at suitable intervals.
11. Appropriate steps shall be taken to protect animals in case of fire or other emergencies and all equipment susceptible to damage by frost shall be suitably protected.
12. A suitable warning notice shall be displayed at the entrance to the enclosure indicating the presence of Dangerous Wild Animals.

13. The Licence Holder shall provide and maintain public liability insurance to the satisfaction of the Service Manager Trading Standards throughout the term of the Licence.
14. Suitable accommodation to the satisfaction of the Official Veterinary Surgeon shall be provided within the enclosure for use by farrowing sows.
15. A written escape procedure shall be produced and maintained and copies of it and any subsequent amendments to it shall be provided to the Licensing Authority, the Police Authority and all Authorised Key Holders.
16. A record of all escapes shall be kept together with the results of subsequent investigations and reviews of security. This record shall be made available to Duly Authorised Officers of the Licensing Authority on request.
17. A copy of the Licence shall be kept available for inspection by any person empowered by the Council to inspect the premises, or who is authorised by the terms of the Licence to have custody of the animals.
18. The Council reserve the right to amend any of the above conditions, subject to adequate notice being granted to the Licence Holder.
19. The person to whom the Licence is granted, or any Authorised Keeper shall immediately notify the Police and the Licensing Authority in the event of any animal to which the Licence relates escaping from the confinements of the licensed premises.
