PREMISES LICENCE HOLDER: SUSAN SLOAN

1. Reason for Report

As the Board has received a premises licence review application and the Convener has determined that the application should not be rejected, the Board must hold a Hearing.

2. Background

- 2.1 The Board received an application for a Premises Licence Review from Police Scotland on 17 September 2024 in respect of the above-named premises (**Appendix 1**).
- 2.2 Where the Board receives an application for a Premises Licence Review it must hold a Review Hearing within 42 days of the date of the application, unless the Board rejects the application as being vexatious or frivolous or does not disclose any matter relevant to any ground for review.
- 2.3 The Convener has determined that the application should not be rejected.
- 2.4 In terms of legal procedure, Notice of the Hearing and a copy of the Premises Licence Review Application were forwarded to both the Licence Holder and Licensing Standards Officer (LSO) and Notice of the Hearing has also been given to Police Scotland.
- 2.5 The statutory LSO report that the Board is legally obliged to take into account is detailed at **Appendix 2.**

3. Determination

3.1 As democratically elected individuals, ultimate decision making power rests with elected Members and not Council Officers. Whilst Officers can give advice, they cannot clearly make decisions at Hearings. Ultimately, the Board must come to a lawful decision taking into account the following:

3.2. Grounds for Review

The Board must be satisfied that a ground of review is established in the first instance and the grounds for review are:

- that, having regard to the licensing objectives, the licence holder is not a fit and proper person to be the holder of a premises licence;
- that one or more of the conditions to which the Premises Licence is subject has been breached; or
- any other ground relevant to one or more of the Licensing Objectives (those Objectives being):
 - (a) Preventing Crime and Disorder
 - (b) Securing Public Safety
 - (c) Preventing Public Nuisance
 - (d) Protecting and Improving Public Health
 - (e) Protecting Children and Young Persons from Harm.

PUBLIC

3.3. Board's Powers on Review

At a Review Hearing, if the Board is satisfied that a ground for review has been established (whether or not on the basis of any circumstances alleged in the Premises Licence Review Application) the Board <u>may</u> take any of the following steps as are considered <u>necessary</u> or <u>appropriate</u> for the purposes of any of the Licensing Objectives.

- 3.4 The steps that the Board may take are to:-
 - issue a written warning to the licence holder;
 - make a variation of the licence (the Board can provide that the variation applies for a certain time period only);
 - suspend the licence for such period as the Board may determine
 - revoke the licence.
- 3.5 The above steps take immediate effect.
- 3.6 It is also open to the Board to take no further action even if a ground for review is established.
- 3.7 Where, at a review hearing in relation to any premises licence, the Licensing Board are satisfied that, having regard to the licensing objectives, the licence holder is not a fit and proper person to be the holder of a premises licence then the Board <u>must</u> revoke the licence.
- 3.8 This revocation takes effect after a 28 day period beginning with the day on which the Board makes the decision unless, during that 28 day period:
 - the premises licence holder makes an application to transfer the licence and the Board grants that transfer; or
 - a variation application is made which seeks to vary the licence and the Board considers that the variation, if granted, would remove the ground on which the licence was revoked.
- 3.9 If the Board receives either of the above applications and grants that application, then the Board must recall its revocation
- 3.10 The Board also retains the power to extend the 28 day period pending determination of either a transfer or variation application.

4. Recommendations

- 4.1 Members are asked to consider
- (i) whether a ground of review exists; and
- (ii) if a ground of review is established, which discretionary steps (if any) it wishes to take as per paragraphs 3. 4 and 3.6 above;
- 4.2 If no ground of review is established then no order can be made.

In terms of section 36(1) of the Licensing (Scotland) Act 2005 I hereby make application to the Nithsdale Licensing Board for a review of the premises licence in respect of the premises known as Hole In The Wa' Inn, 156 High Street, Town Centre, Dumfries, DG1 2BA.

This application for review is made in terms of Section 36(3) (b) on grounds relevant to one or more of the licensing objectives as articulated at Section 4(1) of the 2005 Act, namely:

- Preventing crime and disorder
- Securing Public Safety

Have been breached.

In support of this application, and in terms of section 36(5A) the following information is provided for your consideration: -

The Hole In The Wa premises was placed onto a six month intervention plan on 03 May 2024, by Police Scotland, due to a of series of incidents of violence, general drunkenness and serious concerns relating to staff training and housekeeping.

Over a 4 month period (Jan – April) There were 18 incidents recorded which identified that there was a risk to public and staff safety should the premises continue to operate as it was with these ranging from;

- Sexual Crime

- Drunkeness
- Assaults
- Disturbances
- Fail to Leave Premises

Two of the recorded incidents were more of a serious matter as follows:

At 2120 hours, On Saturday 03rd February 2024, Police were requested to attend due to a male causing a disturbance within the premises and being restrained by two male members of staff. During Police enquiries it was established that neither of the males who had been hands on held a valid Door Supervisor SIA Licence and had been ejecting people. They were then cautioned and charged with assault and informed that they would be reported for Section 3 of the Private Industry Security Act 2001(carrying out a licensable activity without an SIA Licence).

At 0041 hours, on Sunday 21st April 2024, Police were contacted by the Scottish Ambulance Service Control reporting they were attending at the Hole in the Wa' due to the report of a male who had been glassed.

Through Police enquiries it was established that the victim had been heavily intoxicated and pushed two females to the ground which resulted in a short fight occurring with a doorman being assaulted however no one on this occasion was ejected and they continued drinking and socialising up until a second fight broke out resulting in the male victim being struck over the head with a glass bottle and punched in the face. It was later found that as a result of this altercation the victim had a broken jaw and required to have his head glued.

Police Scotland recommended that the premises should:

- Increase monitoring inside and outside the premises to remove drunk individuals as required
- More close monitoring of patrons and their consumption of alcohol on the premises and early intervention to prevent drunkenness
- Ensure CCTV is fully operational
- More robust action to be taken by staff when dealing with those involved in incidents and continuing to contact Police Scotland to prevent criminality.
- Ensure staff are fully up to date in relation to actions after an incident, I.E preserving a crime scene, reporting to the Police, providing statements etc.
- Ensure staff are aware of licensing hours and their obligations around drunkenness.
- Ensure staff are aware of those who are subject to previous incidents and ensuring the refusal register is updated and fit for purpose.
- Regular checks of the toilets for drug misuse.
- Ensure door stewards are fully accredited through SIA and trained in de-escalation.
- Ensure robust checks are undertaken in respect of age verification in accordance with the challenge 25 policy.

These actions were agreed by the premises designated manager Alan Houliston.

The premises performance improved over the following three months and a positive review was completed with them on 01st August 2024, whereby Alan Houliston confirmed that they would continue to maintain these standards for the remaining three months of the intervention plan.

On Tuesday 13th August 2024, Police Scotland were completing enquiries into a serious and violent crime committed at a separate licensed premises in Dumfries and it was brought to Police attention that a violent crime had been committed by the same accused earlier in the evening within The Hole in the Wa', 156 High Street, Dumfries.

On the evening of Friday 09th August 2024, Security Staff at The Hole In The Wa recorded within their incident book that a male person had been removed from the premises after a glass had been thrown at another male injuring his head.

CCTV was reviewed by Police, and this incident had been captured on both cameras covering the lounge area, whereby it showed the accused male sat at a table near to the dancefloor in company of two other males. The footage shows a prolonged heated discussion between the victim and accused which results in the accused picking up a glass from a table and throwing it at the victim. It is unclear if the glass connects with the victim, but the accused grabs the back of his head. Nearby Security Staff thereafter remove the accused.

The victim is then observed to sit down, and blood can be seen on the back of their neck, and they leave the premises thereafter.

The victim was later conveyed to hospital due to a cut to the back of his head which would not stop bleeding. Where four staples were utilised to close the wound.

Police Officers spoke with the responsible personal licence holder in charge of the premises on this evening namely Ms Forteath and the two door stewards on duty who confirmed that this incident was not reported to the Police and the locus had been cleaned up.

Due to the premises failing to contact Police after this incident the accused has been free to attend other licensed premises where a further serious crime occurred, which resulted in another victim being admitted to hospital with initial life threatening injuries. The premises within the Hole In The Wa was also cleaned up and there were not forensic evidence opportunities as a result.

The latest assault in the premises remains sub judice with no further information able to be disclosed at this juncture.

This premises was previously performing poorly, and incidents of drunkenness and violence were high, the premises was given relevant advice on how to improve and given the opportunity to implement this. This most recent and serious incident shows that this premises continues to fail to prevent crime and disorder and safeguard its own patrons.

Since the premises was placed on the intervention on 03rd May 2024, the premises has had 26 Police inspections completed all of which were positive apart from one that mentioned drunkenness was apparent. There have also been 9 incidents documented at the premises.

Due to this I request that the Licensing Board considers the aforementioned grounds for review and takes such steps as it considers necessary or appropriate for the purposes of the Licensing Objectives under the terms of Section 39(2) or 39(2A) of the Act.

- 1. Ms Susan Sloan has held the licence for these premises since 23 October 2020. The Designated Premises Manager is Alan Houliston, 5 Carlyle Court, Dumfries, DG1 3FL, personal licence number DG/N/0123.
- 2. The premises operate as a public house. The building consists of a public bar, lounge bar/restaurant and external beer garden.
- 3. The licensed hours for the premises are: -

On Sales

Monday to Saturday 0930am – 0100am Sunday 1100am – 1200am

Off sales

Monday to Sunday 1000am – 1000pm

- 4. The occupant capacity of the premises is 150.
- 5. LSO visits During the past 11 months, I have called at the premises as follows.
 - 05.10.23 Routine compliance inspection with Mr Houliston, staff training, relevant signage, and production of appropriate documentation all in order.
 - 11.10.23 Breach of Mandatory Condition 8 (2)(h) which related to wording on a social media post offering a free alcohol drink with a karaoke. This was pointed out to Mr Houliston and immediately rectified. No alcohol was dispensed as per the advert which was removed.

Review application

6. On Thursday 19 September 2024, I met with Ms Susan Sloan and Mr Alan Houliston, and prior to any discussion taking place regarding the review application submitted by the Chief Constable, I conducted a routine compliance inspection at the 'Hole i' the Wa' premises.

All staff training, relevant signage and documentation produced was found to be in order. There were no issues or concerns highlighted from an LSO perspective from the compliance inspection.

- 7. Ms Sloan thereafter confirmed she was the Premises Licence holder and her partner Mr Houliston the Designated Premises Manager (DPM). With regard to the review application, Ms Sloan confirmed the following.
- 7.1 Ms Sloan recognised there had been previous issues with security in the premises earlier this year and as such employed a new company called ELDA from Carlisle. Ms

Sloan confirmed they have increased security numbers on a Friday night to two stewards and a Saturday night to three stewards.

- 7.2 As a result of the security and stewarding issues, Ms Sloan also confirmed that Mr Houliston, has recently sat and passed his SIA Licence, 'Non-Front Line' which is a licence for those who are employers and supervisors.
- 7.3 The premises is currently subject to a Police Scotland Intervention Plan.
- 7.4 Ms Sloan and Mr Houliston accepted that the Intervention plan was a good thing for them, and they embraced this, carrying out increased regular meetings with staff.
- 7.5 Ms Sloan noted that Police visits were all positive during this time and was also recognised by Mr Houliston who is more hands on with regard to the premises in his role as DPM. The role of a DPM is being responsible for the day to day running of the premises, training and supervision of staff and ensuring the premises is run in accordance with the requirements of the licence.
- 7.6 Regarding the incident on 09.08.24. Both Ms Sloan and Mr Houliston confirmed they were on a family holiday out of the area. The premises were being supervised by Ms Lucy Forteath (Personal Licence Holder).
- 7.7 Ms Sloan and Mr Houliston stated to me that they were extremely disappointed and upset to hear of the incident in the premises and that the actions of their staff did not meet their expectations. That said Ms Sloan did confirm that she was fully responsible for this as the Premises Licence Holder.
- 7.8 Ms Sloan stated that they take the licensing objectives and review extremely seriously. As a result, both Mr Houliston and Ms Sloan have held a meeting with Ms Forteath and the security company. They stated to me they have established the following from their own enquiries: -
 - The steward dealing with the incident believed Police had been called by Lucy Forteath and Ms Forteath believed Police had been called by the stewards.
 - For reasons not known to them, Radio Link was not used to contact the Police.
 Radio Link is not always available for contacting Police but accept a 999 or 101 call should have been made to Police immediately.
 - Both Ms Forteath and the supervisor steward admitted to them that they did not realise the seriousness of the injury sustained.
 - This communication issue clearly identified by Ms Sloan and Mr Houliston meant they have now rectified this with a clear process that has been explained to staff whereby the supervisor or most senior Personal Licence Holder should call the Police regardless.
 - All staff have been briefed regarding the incident and ensure learning is understood by all.
 - The suspect who was responsible and others in his group that night have received a lifetime ban from the premises.
 - The incident is clearly recorded on the incident log held within the premises and it also states the Police did a walk through of the premises an hour later. **I also inspected the incident book and noted the entry was signed and dated by a member of staff **

7.9 Ms Sloan also wished to advise me that they have twelve bar staff and eight are now Personal Licence Holders. They are hoping to secure another two staff on the personal licence course as they believe this should provide more skill and reassurance for her as Premises Licence holder.

8. Recommendation

That the Board have regard to the information provided in reaching its decision in the Premises Licence Review.

LICENSING (SCOTLAND) ACT 2005 (THE ACT): SECTION 84A CONDUCT INCONSISTENT WITH THE LICENSING OBJECTIVES PERSONAL LICENCE HOLDER: LUCY FORTEATH

1. Reason for Report

As the Board has received a section 84A report from the Chief Constable it must, in law, hold a Hearing.

2. Background

- 2.1 On 17 September 2024, the Chief Constable, in terms of his power under section 84A the Act, submitted to the Board a report alleging that Lucy Forteath, the holder of a personal licence, has acted in a manner that is inconsistent with the licensing objectives, (a) Preventing Crime and Disorder and (b) Securing Public Safety (**Appendix**).
- 2.2 A Personal Licence issued by a Licensing Board authorises the licence holder to supervise or authorise the sale of alcohol.
- 2.3 In terms of procedure, both the letter and Notice of Hearing have been sent to the licence holder.

3. Determination

- 3.1 At its Hearing the Board may, after giving
 - the licence holder concerned and
 - such other persons as they consider appropriate an opportunity to be heard
 - if satisfied that it is necessary to do so for the purposes of any of the licensing objectives, make an order to:
 - a) revoke the licence;
 - b) suspend the licence for a maximum 6 month period as the Board considers appropriate; or
 - c) endorse the licence. (an endorsement expires after five years)
- 3.2 It is also open to the Board to take no action.
- 3.3 If, at the Hearing, the Board is satisfied that, having regard to the licensing objectives, the licence holder is not a fit and proper person to be the holder of a personal licence then the Board must make an order revoking the licence.

4. Recommendations

- 4.1 Members are asked to consider whether they wish to:
- revoke
- suspend
- endorse the licence or
- take no action; and
- 4.2 Note that if a determination is made that the licence holder is not a fit and proper person to be the holder of the personal licence then the Board has no discretion as to which action it wishes to take as it must, in law, revoke the licence.

The Chief Constable hereby reports to the Licensing Board in terms of Section 84A of the Licensing (Scotland) Act 2005 that Ms Lucy Forteath, has acted in a manner which is inconsistent with the licensing objective(s) articulated at Section 4(1) of Act, namely:

- Preventing Crime and Disorder
- Securing Public Safety

Ms Forteath holds a Personal Licence which was issued by the Nithsdale Licensing Board on 26th August 2022 and is due to expire on 25th August 2032. At the time of the incident being reported she was working within the Hole in the Wa', 156 High Street, Dumfries.

The following information is provided for the Board's consideration.

During enquiries on 13th August 2024, with regards to a serious and violent crime committed at a separate licensed premises in Dumfries, it was brought to Police attention that a violent crime had been committed by the same accused earlier in the evening within the Hole in the Wa', 156 High Street, Dumfries.

On the evening of Friday 09th August 2024, Security Staff at The Hole in The Wa recorded within their incident book that a male person had been removed from the premises after a glass had been thrown at another male injuring his head.

CCTV was reviewed by Police, and this incident had been captured on both cameras covering the lounge area, whereby it showed the accused male sat at a table near to the dancefloor in company of two other males.

The footage shows a prolonged heated discussion between the victim and accused which results in the accused picking up a glass from a table and throwing it at the victim. It is unclear if the glass connects with the victim, but he appears to grab the back of his head. Nearby Security Staff thereafter remove the accused.

The victim is then observed to sit down, and blood can be seen on the back of their neck, and they leave the premises thereafter.

The victim was later conveyed to hospital due to a cut to the back of his head which would not stop bleeding, where four staples were utilised to close the wound.

Police Officers spoke with staff at the Hole In The Wa', and it was unclear at that time if this incident had been reported to Police. It was established that Lucy Forteath had been on duty on 09th August 2024.

Police Officers spoke with Ms Forteath and the two door stewards on duty on that evening, who confirmed that this incident was not reported to the Police and the premises had been cleaned up resulting in there being no forensic evidence opportunities.

Due to Ms Forteath failing to contact Police, an opportunity was missed to prevent the male attending at other licensed premises. On this occasion the male did assault a further male outside licensed premises, where the victim was conveyed to hospital with initial lifethreatening injuries.

Due to this lack of action from a Personal Licence Holder who has completed relevant training and is in a position of authority and responsibility in respect of her patrons, public safety has been jeopardised and further serious crimes committed.

Ms Forteath would be well aware of her requirement to adhere to the Licensing Objectives and co-operate with Police Scotland by reporting incidents which occur on the licensed premises. Her conduct in this incident falls far below what could be reasonably expected of a licence holder working within one of the busier premises within Dumfries Town Centre.

Further to this I have to report that on 03rd September 2024, Lucy Forteath contacted the Police Service of Northern Ireland and was later traced and arrested in Belfast due to Attempted Criminal Damage and being intoxicated in public, she was held in custody overnight to appear at Laganside Magistrates Court the following day.

From checking Policing systems, we can see that the charge of attempted criminal damage is still pending and therefore is sub judicial and the charge of being intoxicated in a public place has been marked as no further action.

This additional incident increases concerns regarding Lucy Forteath's suitability as a Personal Licence Holder.

It is Police Scotland's opinion that the Board should consider all the options open to them under Section 84(7) or 84(7A) of the Act.
